9. Planning Updates

9.1 Pending The Little House, 31 School Lane 21/03000/FUL Enlargement of parking area; erection of retaining wall

After discussion it was agreed the *new*, as yet unsubmitted drainage plan needed to be approved by County Highways and as such further representation should be made.

9.2 Pending The Willows, Spring Lane 21/03245/FUL

Erection of a detached garage, single storey rear extension and first floor side extension

This application was validated at the beginning of December with a response required by 24/12. TG declared himself a near neighbour, therefore BR led on the PC Representation.

January Update: The proposed detached garage has been withdrawn. The proposed extensions are thought to meet the requirements of the SDC guidelines 'Extending Your Home' and as far as could be judged they do not create any unreasonable 'impact on neighbours' ~no concerns have been raised by others. Therefore, the Parish Council 's representation is not to object to Officers' determination of this application.

13 The Leys

The Leys Management Group met at the beginning of December. Prior to the meeting the WCC Habitat Biodiversity Audit Partnership (HBA) were consulted about the proposal on the trees. Also, there is now a proposal to progress the original advice from HBA in 2012 to consider reinstating the pond.

HBA advice was that general policy on good grassland sites was to avoid planting trees in order to allow the grassland to thrive but they felt that there was scope for a few hedge trees at the top but it should be kept small scale. They also gave further advice on the appropriate species. There was also an offer by a senior officer to visit the site and review the proposals with us, visit proposed for Jan/Feb.

It was agreed at the December meeting following the species advice given to plant a small group of trees around the corner area. It was also agreed to pursue in 2022 the establishment of some pond life, keeping appropriate awareness of safety matters regarding water areas and liaising with HBA.
